1. Ans) (b)

Explanation:

MSP is a price fixed by the Government of India for the farmers when it procures any crop from them. It is actually fixed before the sowing season to encourage higher investment in agriculture. It is based on the recommendations of the Commission for Agricultural Costs and Prices (CACP).

2. Ans) (c)

Explanation:

Goa becomes the 6th State to complete Urban Local Bodies (ULB) reforms. Gets additional borrowing permission of Rs. 223 crore. Goa has joined five other States namely, Andhra Pradesh, Madhya Pradesh, Manipur, Rajasthan and Telangana, who have completed ULB reforms. Background: Reforms in ULBs and the urban utilities reforms are aimed at financial strenghtening of ULBs in the States and to enable them to provide better public health and sanitation services to citizens. Economically rejuvenated ULBs will also be able to create good civic infrastructure.

3. Ans) (c)

Explanation:

India and China have reached an agreement on disengagement in the Pangong lake area to cease their forward deployments in a phased, coordinated and verified manner. As per the agreement:

The Chinese side will keep its troop presence in the North Bank area to east of Finger 8. Reciprocally, the Indian troops will be based at their permanent base at Dhan Singh Thapa Post near Finger 3. A similar action would be taken in the South Bank area by both sides. Any structures that had been built by both sides since April 2020 will be removed and the landforms restored. Both sides have agreed on a temporary moratorium on military activities in the North Bank, including patrolling in the traditional areas. The Line of Actual Control (LAC) – the line that separates Indian and Chinese troops since 1962 – generally runs along the land except for the width of Pangong Tso. Here, it runs through water. Both sides have marked their areas announcing which side belongs to which country. India controls about 45 km stretch of the Pangong Tso and China the rest.

NITI Aayog has constituted a sub-group to prepare a National Action Plan for Migrant Workers.

OSH Code Inter-state Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 was subsumed in the Occupational Safety, Health and Working Conditions Code, 2020 (OSH Code) The Code was notified in September 2020 Provision of OSH Code: Decent working conditions, minimum wages, grievances redressal mechanisms, protection from abuse and exploitation, enhancement of skills, and social security. Target: All categories of organised and unorganised workers including Migrant workers. Applicability: Every establishment in which 10 or more inter-state migrant workers are employed or were employed on any day of the preceding 12 months.

Explanation:

Recently, Mallikarjun Kharge is appointed as the leader of opposition in Rajya Sabha.

The Leader of the Opposition (LoP) is the politician who leads the official opposition in either House of the Parliament of India. The Leader of the opposition is the parliamentary chairperson of the party with the most seats after the government party. While the position also existed in former Central Legislative Assembly of British India, and holders of it there included Motilal Nehru, it received statutory recognition through the Salary and Allowances of Leaders of Opposition in Parliament Act, 1977 which defines the term "Leader of the Opposition" as that member of the Lok Sabha or the Rajya Sabha who, for the time being, is the Leader of that House of the Party in Opposition to the Government having the greatest numerical strength and recognised, as such, by the Chairman of the Rajya Sabha or the Speaker of the Lok Sabha. Clause 4 of The Central Vigilance Commission Act, 2003, provides for the leader of the largest opposition party to be inducted as a member of the selection committee in a scenario where the lower house of parliament does not have a recognised leader of the opposition.

7. Ans) (a)

Explanation:

An Inner Line Permit is a document that allows an Indian citizen to visit or stay in a state that is protected under the ILP system. The system is in force today in three North-eastern states — Arunachal Pradesh, Nagaland and Mizoram — and no Indian citizen can visit any of these states unless he or she belongs to

that state, nor can he or she overstay beyond the period specified in the ILP. The concept comes from the colonial area. Under the Bengal Eastern Frontier Regulation Act, 1873, the British framed regulations restricting the entry and regulating the stay of outsiders in designated areas. This was to protect the Crown's own commercial interests by preventing "British subjects" (Indians) from trading within these regions. In 1950, the Indian government replaced "British subjects" with "Citizen of India". This was to address loval concerns about protecting the interests of the indigenous people from outsiders belonging to other Indian states. An ILP is issued by the state government concerned. It can be obtained after applying either online or physically. It states the dates of travel and also specifies the particular areas in the state which the ILP holder can travel to.

10. Ans) (a)

Explanation:

Government has proposed bringing in a law on cryptocurrencies so as to put an end to the existing ambiguity over the legality of these currencies in India.

What is cryptocurrency?

A cryptocurrency is a digital or virtual currency that is secured by cryptography, which makes it nearly impossible to counterfeit or double-spend. Many cryptocurrencies are decentralized networks based on blockchain technology—a distributed ledger enforced by a disparate network of computers The

government has, from time to time, suggested that it does not consider cryptocurrencies to be legal tender. The disapproval of cryptocurrencies by government is due to fact that such currencies are highly volatile, used for illicit Internet transactions, and wholly outside the ambit of the state. In 2018, the RBI did send a circular to banks directing them not to provide services for those trading in cryptocurrencies. Those challenging the RBI Circular in Supreme Court had argued that these were commodities and not currencies. Therefore, RBI did not have the jurisdiction. The circular was set aside by SC, which found it to be "disproportionate". Regulatory bodies like RBI and Sebi etc also don't have a legal framework to directly regulate cryptocurrencies as they are neither currencies nor assets or securities or commodities issued by an identifiable user
