Alternative Investment Fund

Anything alternative to traditional forms of investments gets categorized as alternative investments. In India, AIFs are defined in Regulation 2(1)(b) of SEBI (Alternative Investment Funds) Regulations, 2012. It refers to any privately pooled investment fund, (whether from Indian or foreign sources), in the form of a trust or a company or a body corporate or a Limited Liability Partnership (LLP), which are not presently covered by any Regulation of SEBI governing fund management nor coming under the direct regulation of any other sectoral regulators in India. Thus, the definition of AIFs includes venture Capital Fund, hedge funds, private equity funds, commodity funds, Debt Funds, infrastructure funds, etc.

He received the Nobel Prize in Physics (1983) alongside William A. Fowler for his theoretical studies of the physical processes of importance to the structure and evolution of the stars. The Chandrasekhar limit is also named after him. The concept gives the maximum mass of a stable white dwarf star. When a star like our Sun exhausts its nuclear fuel, it collapses into a compact, brilliant star known as a white dwarf.

India now has its highest altitude herbal park, which sits at a height of 11,000 feet near the Indo-China border in Uttarakhand's Chamoli district. The park has around 40 species found in high altitude alpine areas in the Himalayan region and other important medicinal herbs. It also has many plant species which are endangered and threatened as per the red list of the International Union for Conservation of Nature and also State Biodiversity Board. It includes many important medicinal herbs also. Medicinal plants have a great deal of importance for the country as these are not only a major resource base for India's herbal and medicine industry but support livelihood and ensure health security for a large segment of Indian population. According to National Medical Plants Borad, AYUSH Ministry, roughly 1178 species of medicinal plants are estimated to be in trade. Of these, 242 species have annual consumption levels in excess of 100 metric tons/year.

The India Meteorological Department requires that temperatures should reach at least 40°C in the plains and at least 30°C in the hilly regions, and should reflect an increase of at least 5°C-6°C above the normal temperature to be classified as a heatwave.

Bhindawas Wildlife Sanctuary, the largest wetland in Haryana is a human-made freshwater wetland. Over 250 bird species use the sanctuary throughout the year as a resting and roosting site. The site supports more than ten globally threatened species including the endangered Egyptian Vulture, Steppe Eagle, Pallas's Fish Eagle, and Black-bellied Tern.
